

OFFICIAL RULES FOR THE “Renew To Win”

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING

SWEEPSTAKES PERIOD: Renew To Win (“Sweepstakes”) begins on September 17, 2018 at 12:01 a.m. Eastern Standard Time (“EST”) and ends on November 10, 2018 at 11:59 p.m. EST (the “Sweepstakes Period”).

HOW TO ENTER: During the Sweepstakes Period, there are 2 ways to enter: (1) Renew your 2019 NASCAR Cup Series race tickets by mail, phone or website to receive one (1) entry into the Sweepstakes or (2) Via Mail: Handprint your name, address, city, state, zip code, daytime and evening phone numbers (including area codes), and date of birth on a 3" x 5" card and mail the card, with proper postage affixed to: Renew to Win Sweepstakes c/o Chicagoland Speedway, LLC, 500 Speedway Blvd., Joliet, IL 60433. Entries generated by script, macro or other automated, or mechanical, means or by any means which subvert the entry process are void. Limit one (1) entry per person, per email address and per household. Entries received from any person or email address or household in excess of the limitation will be void. All entries become the sole property of the Sponsor. Released Parties (as defined below) are not responsible for lost, late, garbled, incomplete, delayed, illegible or misdirected entries. Incomplete, illegible, or fraudulent entries will be void.

ELIGIBILITY: Sweepstakes is open to legal residents of the fifty (50) United States and the District of Columbia who are of the age of majority or older in the applicable jurisdiction.
