

## OFFICIAL RULES FOR THE “A DAYTONA 500® TICKET REFUND PROMOTION”

**PROMOTION PERIOD:** The “A DAYTONA 500® ticket Refund Promotion” (“Promotion”) begins on February 8, 2019 at 8:01am Central Standard Time (“CST”) and ends on February 17, 2019 at 11:00 a.m. CST (the “Promotion Period”) while supplies last or until the Maximum Aggregate Prize Amount (as defined below) is achieved. Sponsor reserves the right to end the Promotion early and shall post notification of such on its website.

**HOW TO ENTER:** There are two ways to enter: (1) Using the promotional link provided for your driver choice or the applicable promotional code via the CLS ticket page found [here](#) to purchase a single day ticket to the Monster Energy Cup Series race scheduled to be held at Chicagoland Speedway on June 30, 2019. During the Promotion Period (from February 8, 2019 through February 17, 2019 at 11:00 am cst), participants shall chose one (1) of the following drivers to win the DAYTONA 500® and will be eligible to have the ticket price they paid refunded if [Brad Keselowski](#) promo code: CLSBRAD19; [Joey Logano](#) promo code: CLSJOEY19; [Kevin Harvick](#), CLSKEVIN19; [Chase Elliott](#) promo code: CLSCHASE19; or [Kyle Busch](#) promo code: CLSKYLE19 win the DAYTONA 500® at Daytona International Speedway on February 17, 2019. Offers valid only for single day advanced price tickets to the Monster Energy Cup Series race at Chicagoland Speedway (any season, weekend, upgrades or any other ticket packages / purchases that are made while entering the contest will not be eligible for the refund of the cost of a single day ticket) any winners who enter via the ticket purchase option may receive a refund of their ticket price or may choose instead to receive a Pit Pass for use at the Monster Energy Cup Series (value equal to one advance purchase single day ticket) or (2) Via Mail: You may also register by hand printing your name, address, zip code/postal code, daytime and evening phone numbers, and projected DAYTONA 500® winner from the following: Brad Keselowski; Joey Logano; Kevin Harvick; Chase Elliott; or Kyle Busch on a 3" x 5" card and mailing the card to “Chicagoland Speedway Ticket Refund Promotion” c/o Chicagoland Speedway, 500 Speedway Blvd., Joliet, IL 60433. Card must be received at the address as stated by February 17, 2019 by 11:00 am cst to be eligible for the promotion. Any mail in entries received after February 17, 2019 at 11:00 am cst will not be considered. Any winners who enter via the mail in option will receive a Pit Pass usable at the Monster Energy Cup Series race (value equal to one advance purchase single day ticket). Sponsor is not responsible for lost, late, mutilated, misdirected, or postage-due entries. Incomplete, illegible, or fraudulent entries not considered.
